REHAB & RESTORATION

NIA sees historical norms that continue to produce the same outcomes, as antiquated "soft on crime" practices. So, in the absence of responsible and comprehensive corrections and rehabilitation by current institutions, NIA seeks out gaps and dangerous flaws. We measure approaches to intervene, impact behavioral trends and help families better navigate systems.



Despite 65 million families directly impacted by incarceration & the \$100 billion cost affecting taxpayers, too many people remain distanced from the problem. We call this an "empathy gap." This Informed **Empathy Campaign seeks** to narrow that gap through ongoing mass-communication messaging, interactive events, and rigorous research.

We get involved in projects and initiatives to take advantage of every opportunity to infuse into partner efforts our "working-together" culture. We see these as opportunities to help local stakeholders realize the value of shared resources. an open exchange of ideas, cross utilization of assets, and more coordination in pursuing resources for program sustainability.
